### **Sharing personal data with third parties**

Green Orange does not sell your information to third parties and only provides it if necessary for the execution of our agreement with you or to comply with a legal obligation. With companies that process your data in our order, we conclude a processor agreement to ensure the same level of security and confidentiality of your data. Green Orange remains responsible for these processing operations.

### **Cookies, or similar techniques, that we use**

Green Orange only uses functional cookies and analytical cookies that do not infringe your privacy. A cookie is a small text file that is stored on your computer, tablet or smartphone during your first visit to this website. The cookies we use are necessary for the technical operation of the website and your ease of use. They ensure that the website works properly and remember your preferred settings, for example. Make your passport photo, MRZ (Machine Readable Zone, the strip with numbers at the bottom of the passport), passport number and citizen service number (BSN) black in this copy. This in order to protect your privacy. We respond as quickly as possible, but within four weeks, at your request. Green Orange would also like to point out that you have the opportunity to file a complaint with the national supervisory authority, the Dutch Data Protection Authority.
